Understanding Police Strategies for Responding to Protests.
Role: Principal Investigator with co-PI Dionne Barnes-Proby.
RAND is creating a dataset on the characteristics of protests and associated police activity in the U.S. for the five-year period 2017-2021, and then conducting in-depth case studies in approximately 10 cities to understand police approaches to protests and identify factors that contribute to whether a protest turned violent.
